

## **Inspired extends VLT and Virtual Sports Agreements with OPAP Builds on Success in Greece with Additional VLTs and Virtual Sports Channel**

Furthermore, Inspired has extended the term of its Virtual Sports agreement with OPAP. OPAP will also be adding another Virtual Sports channel to launch Football Matchday™. Football Matchday™ is being customized together with OPAP to provide a product specifically for Greek players. Football Matchday™ is being launched before the end of 2018, alongside Rush Football 2™, which has been offered since April 2017.
