

Inspired Names Steve Beason New Group Chief Technology Officer

He also managed the manufacturing and software development organizations with centers in the US, Europe, India and China.

From 1998 to 2005, Beason was the Executive Director, Information Technology for the Hong Kong Jockey Club where he oversaw the entire IT and MIS organization. Prior to that, Beason served as the Vice President of Software for GTECH from 1986 until 1998, managing the software service, support and development departments. In total Beason has over 35 years of experience in the gaming and wagering industry.

Beason holds an undergraduate degree from Coleman College and received his M.B.A. from the Kellogg School of Management at Northwestern University and the Hong Kong University of Science and Technology.
