OMAHA, Neb., Jan. 21, 2021 (GLOBE NEWSWIRE) -- Green Plains Partners LP (NASDAQ:GPP) today announced that the board of directors of its general partner declared a quarterly cash distribution of \$0.12 per unit on all of its outstanding common units, or \$0.48 per unit on an annualized basis, for the fourth quarter of 2020. The distribution is payable on February 12, 2021, to unitholders of record at the close of business on February 5, 2021.

Please note that 100 percent of Green Plains Partners' distributions to foreign investors are attributable to income that is effectively connected with a U.S. trade or business.
