(NYSE: FERG; LSE: FERG) (the "Company") announced its intention to pay a quarterly dividend of \$0.79 per share ("Q4 Dividend"). The Q4 Dividend will be paid on November 8, 2024, to stockholders of record as of the close of business on September 27, 2024.
