Ferguson Share Repurchase Program - Weekly Report

WOKINGHAM, England--(BUSINESS WIRE)-- **Ferguson plc** (NYSE: FERG, LSE: FERG) (the “Company”) announces today that it purchased a total of 46,587 of its ordinary shares in the period from June 26, 2023, up to and including June 30, 2023, in connection with its \$3.0 billion share repurchase program.

The Company intends to hold these shares in treasury. Following the purchase of these shares (including those purchased but not yet settled), the number of shares held by the Company in treasury will be 27,691,617.

Following the purchase of these shares, the remaining number of ordinary shares in issue will be 204,479,565. The figure of 204,479,565 may be used by shareholders (and others with notification obligations) as the denominator

for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the Disclosure Guidance and Transparency Rules.
