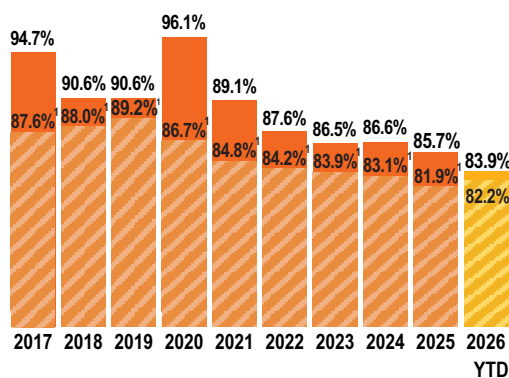
Chubb is a world leader in insurance, providing commercial and personal property and casualty insurance, personal accident and supplemental health insurance, reinsurance and life insurance

P&C Combined Ratio

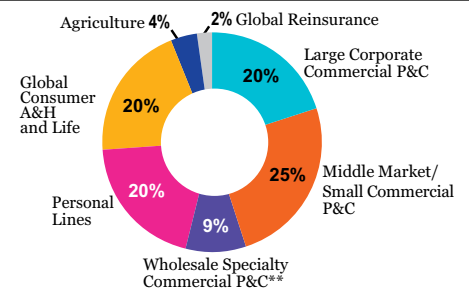

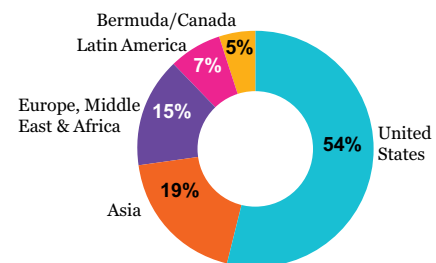
Premium Distribution by Product*
