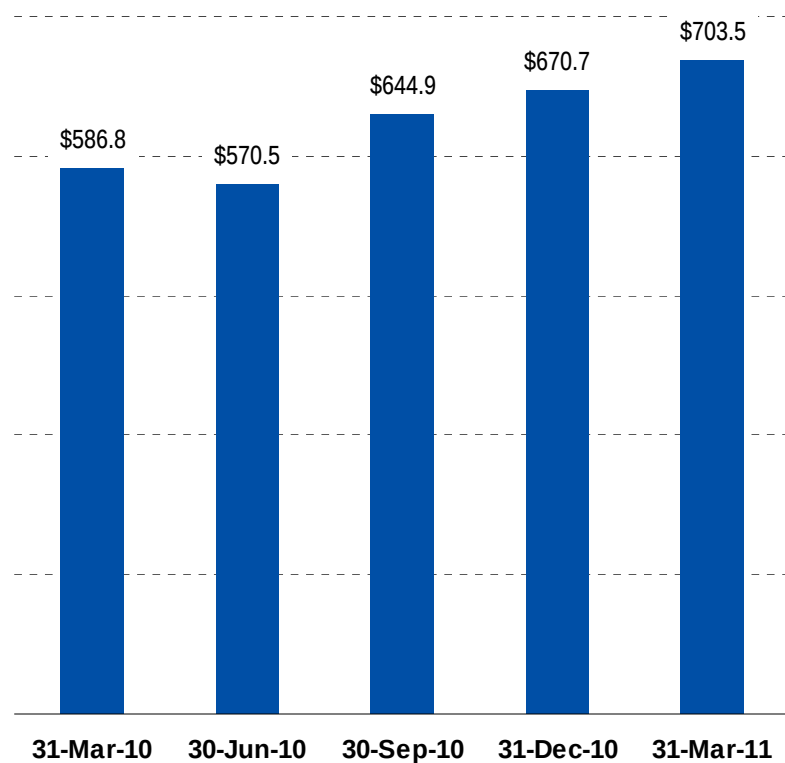
Assets Under Management and Flows



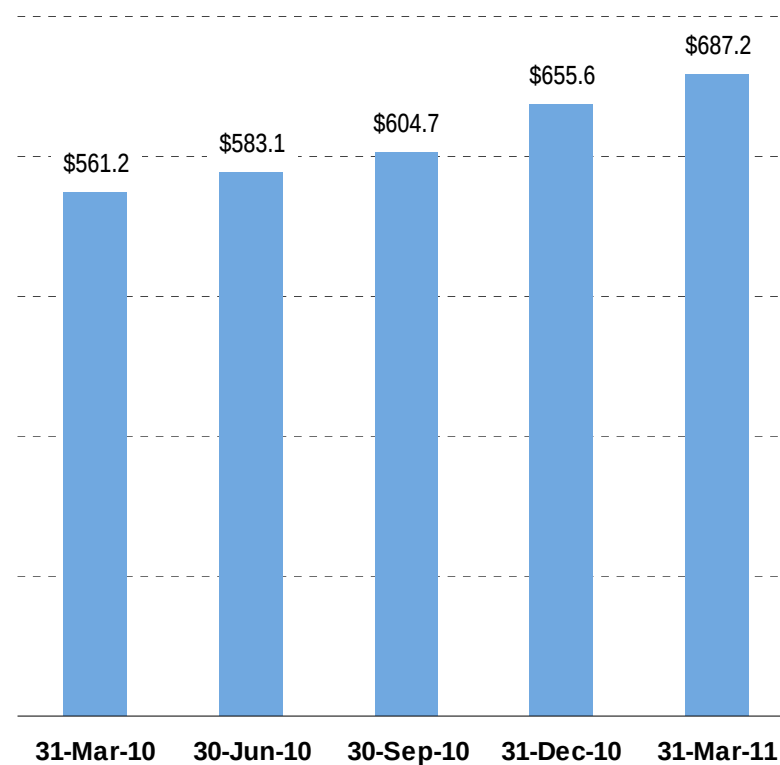
Assets Under Management

End of Period



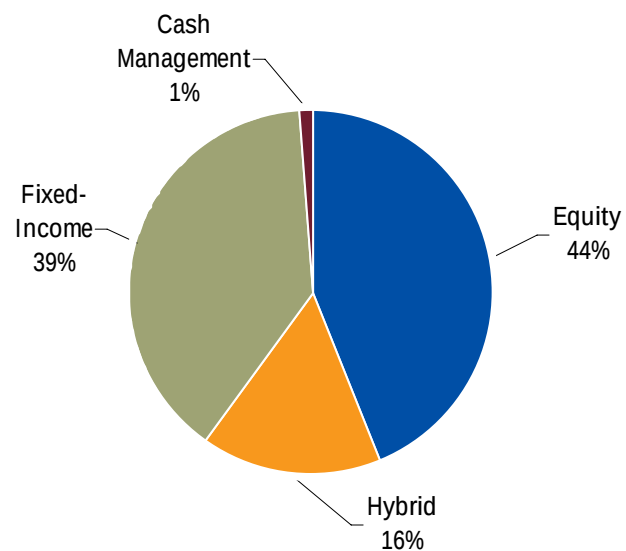
Simple Monthly Average

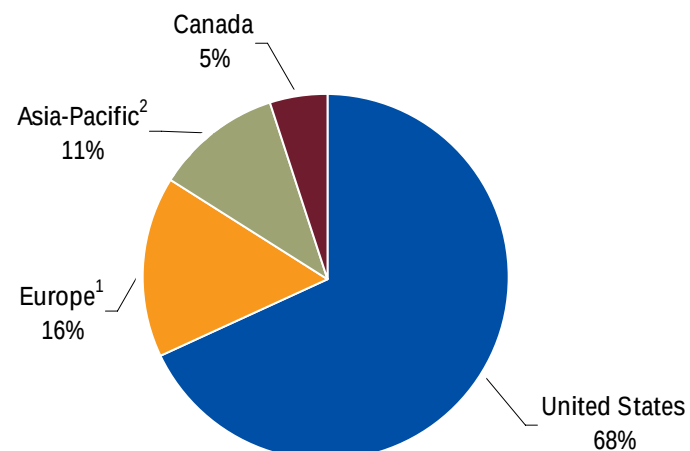

(chart is as of March 31, 2011)



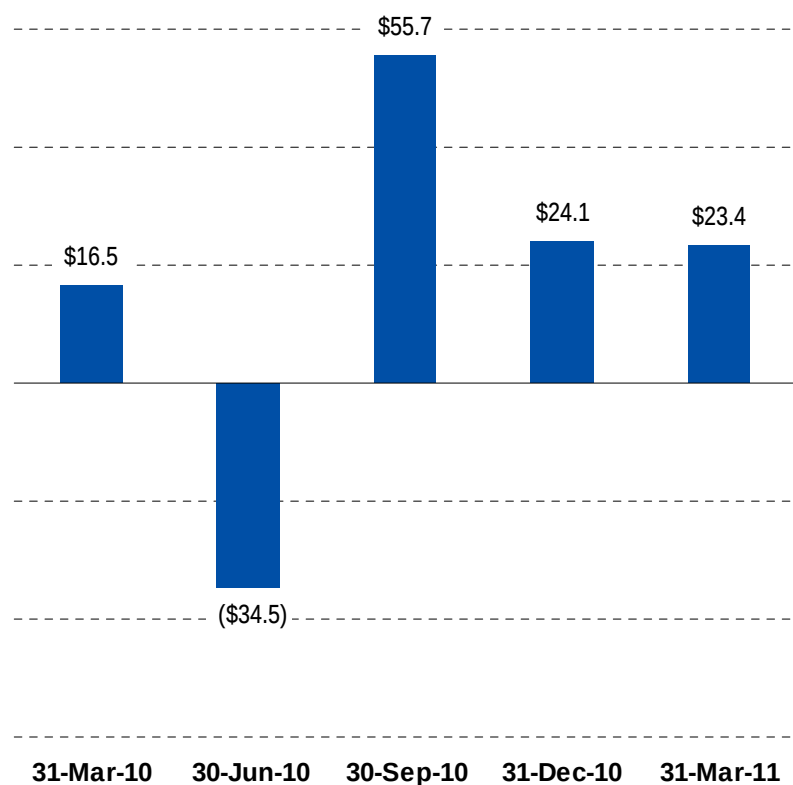

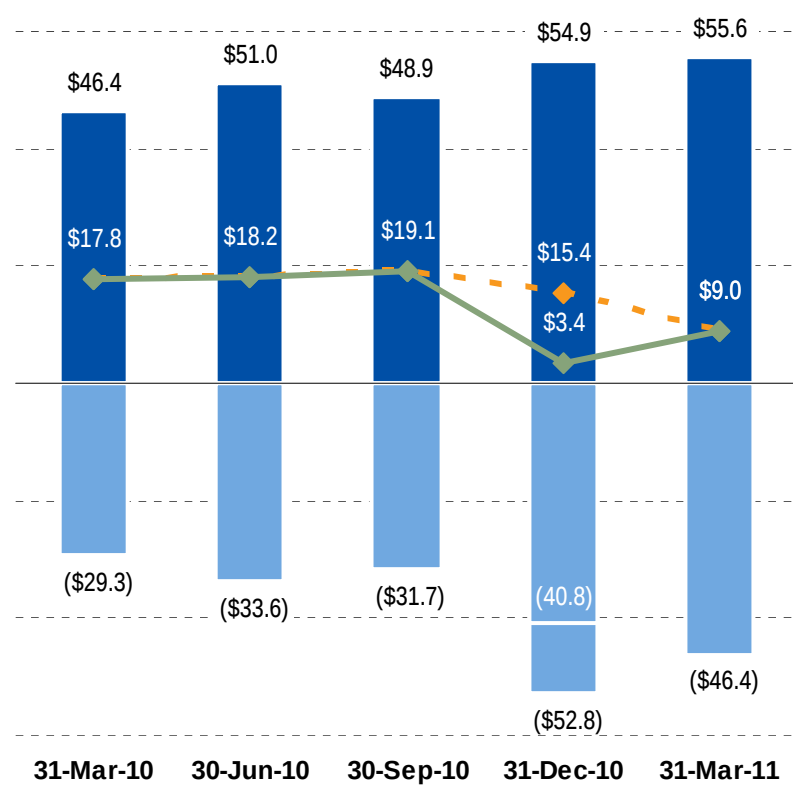

■ Long-Term Sales ■ Long-Term Redemptions

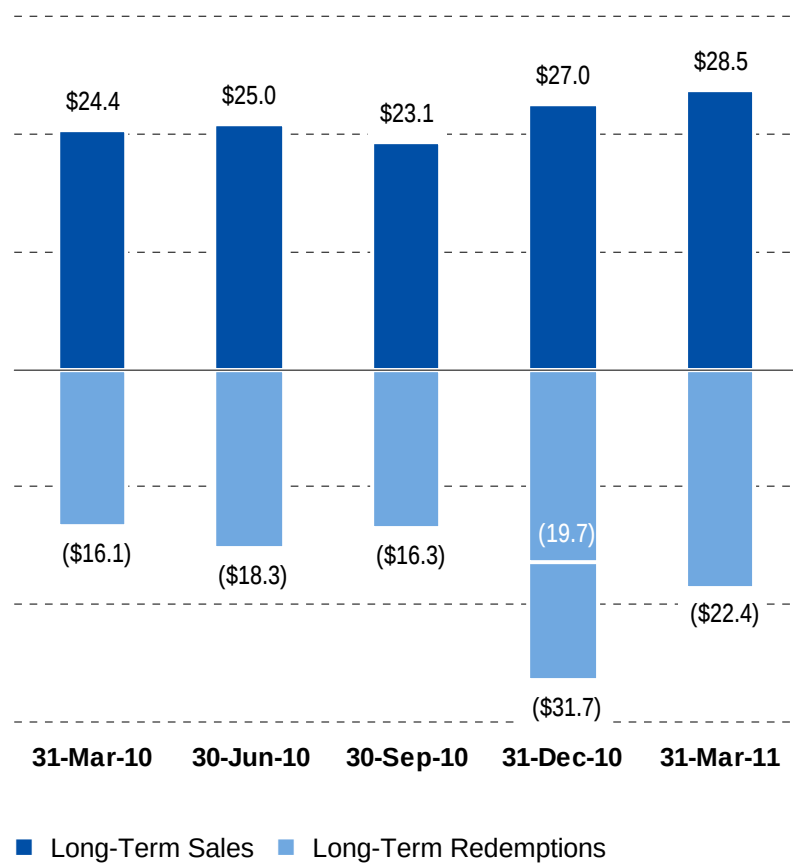

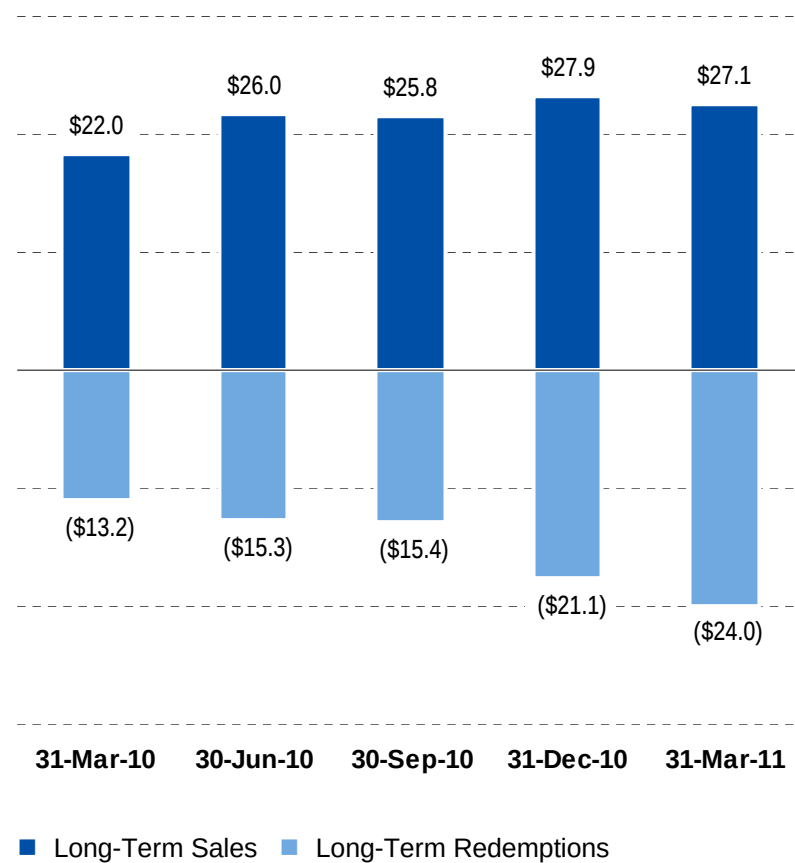
United States and International Flows

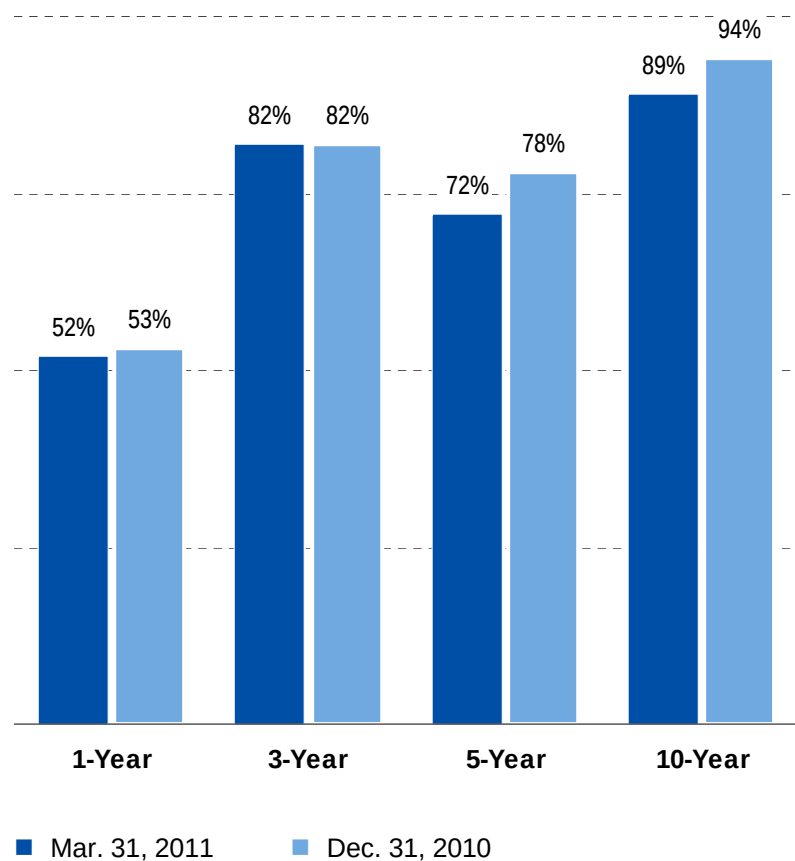

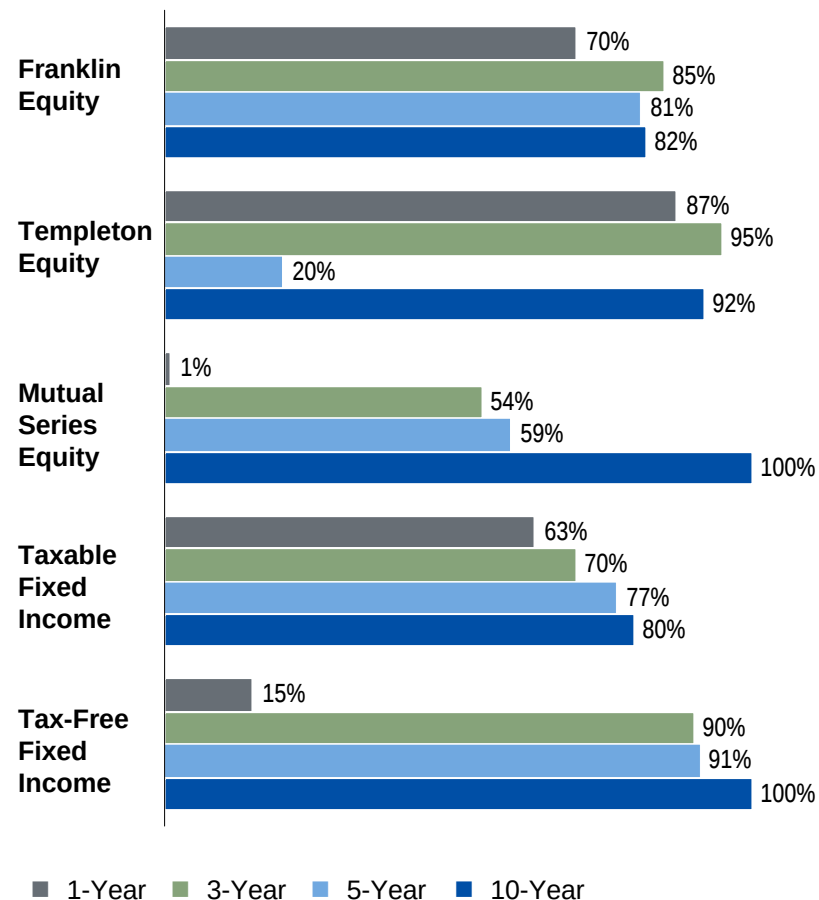
Investment Performance – Lipper Rankings of U.S.-Registered Long-Term Mutual Funds¹

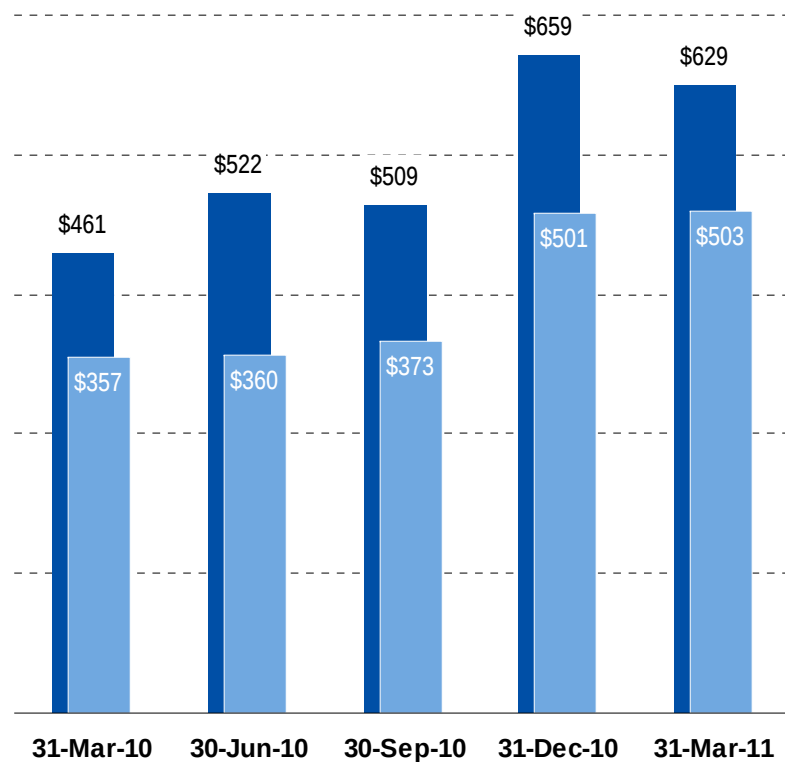

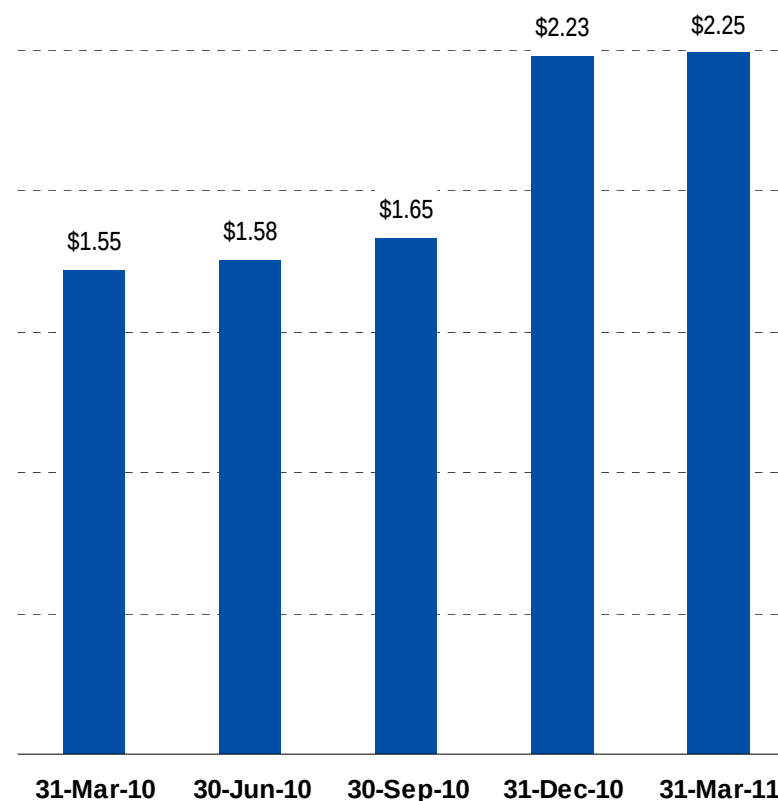

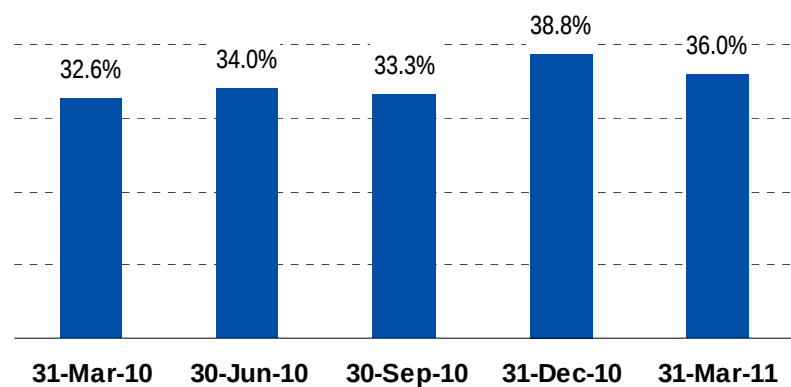

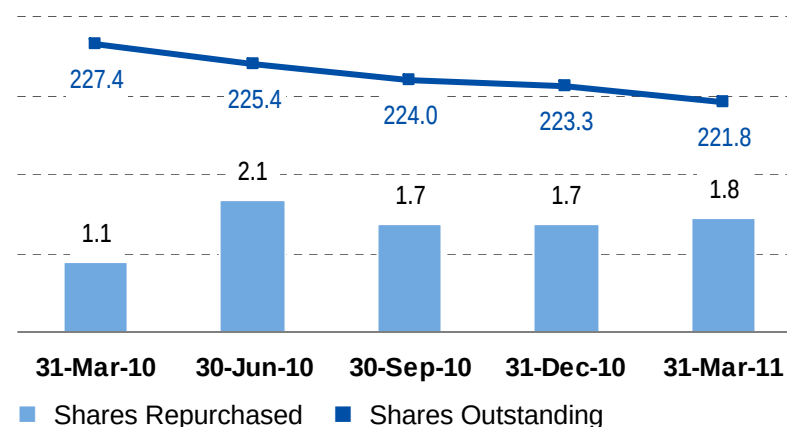
Operating Margin and Capital Management

Quarterly Operating Margin

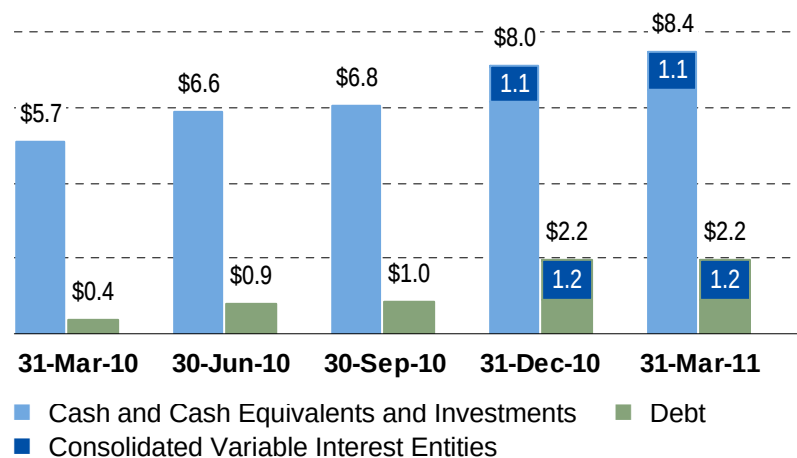


Quarterly Stock Repurchase Activity

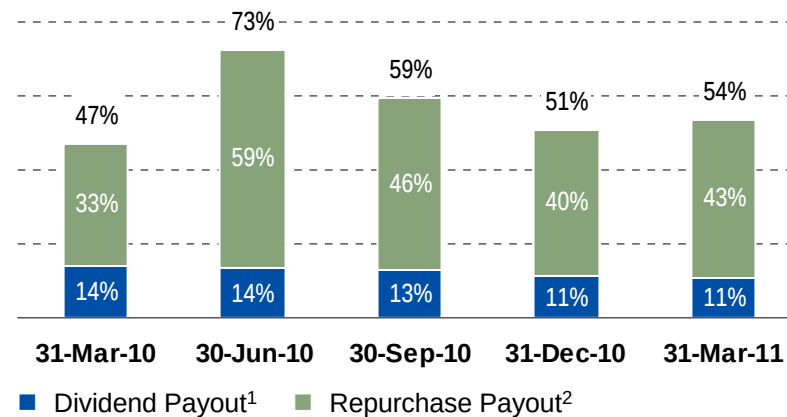


Cash and Cash Equivalents and Investments vs. Debt
