Duke Energy to announce third-quarter 2021 financial results on Nov. 4

CHARLOTTE, N.C. – Duke Energy will announce its third-quarter financial results at 7 a.m. ET on Thursday, Nov. 4, in a news release to be posted on the company's website at [duke-energy.com/investors](https://www.duke-energy.com/investors).

An earnings conference call for analysts is scheduled from 10 to 11 a.m. ET that day to discuss third-quarter 2021 financial results and other business and financial updates.
