## **Political Engagement and Contributions**

Governments around the world take actions that can significantly affect Harley-Davidson and our employees, customers, and shareholders. Harley-Davidson believes it is important to advocate on issues that affect Harley-Davidson's business when it is constructive to do so under the applicable political system. The form of advocacy that we use may differ depending on political systems and local laws. Consistent with company values, Harley-Davidson is committed to full compliance with all federal, state, local, and international political laws and to maintaining the highest ethical standards in the way we conduct our business.

The Harley-Davidson advisory committee, which is comprised of members of the Company's senior leadership, oversees political engagement policies and reviews, on an annual basis, all political contributions made by the company. The Company's advisory committee and senior management are responsible for developing the strategies and the day-to-day decisions and activities involving Harley-Davidson's political engagement. The Company did not make any contributions in 2024 to participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office or to influence the general public with respect to a political election or ballot referendum.

Political contributions are made by nonpartisan state and federal political action committees established by the company but funded solely by voluntary contributions that each committee receives from employees eligible to make contributions under applicable laws. All contributions made by Harley-Davidson political action committees are reviewed and approved by the advisory committee. In 2024, company political action committees made the following contribution in 2024 to participate or intervene in a political campaign on behalf of or in opposition to any candidate for public office or to influence the general public with respect to a political election or ballot referendum:
