MarketAxess Announces Monthly Volume Statistics for July 2015

NEW YORK, Aug. 4, 2015 (GLOBE NEWSWIRE) -- MarketAxess Holdings Inc. (Nasdaq:MKTIX), the operator of a leading electronic trading platform for fixed-income securities, and the provider of market data and post-trade services for the global fixed-income markets, today announced total monthly trading volume for July 2015 of \$81.8 billion, consisting of \$48.8 billion in U.S. high-grade volume, \$28.1 billion in other credit volume, and \$4.9 billion in liquid products volume.

MarketAxess is providing both the reported and adjusted estimated U.S. high-grade TRACE volumes on its website. The Company believes that the adjusted estimated volumes provide a more accurate comparison to prior period reporting.
