



## MarketAxess Announces Monthly Volume Statistics for January 2020

### Company Reports Record Total Credit Monthly Trading Volume and Record Monthly Trading Volume for Open Trading™

NEW YORK, Feb. 04, 2020 (GLOBE NEWSWIRE) -- MarketAxess Holdings Inc. (Nasdaq: MKTX), the operator of a leading electronic trading platform for fixed-income securities, and the provider of market data and post-trade services for the global fixed-income markets, today announced monthly trading volume for January 2020 consisting of \$100.1 billion in U.S. high-grade volume, \$100.2 billion in other credit volume and \$395.7 billion in rates volume.

Record monthly trading volume was achieved in January 2020 for the following categories:

- Total credit average daily trading volume of \$9.5 billion and total trading volume of \$200.3 billion
- Open Trading™ average daily trading volume of \$2.7 billion and total trading volume of \$56.9 billion
- U.S. high-grade average daily trading volume of \$4.8 billion and total trading volume of \$100.1 billion
- U.S. high-yield average daily trading volume of \$1.2 billion and total trading volume of \$25.5 billion
- Emerging markets average daily trading volume of \$2.4 billion and total trading volume of \$51.2 billion
